Please make sure your men are aware of the love offerings that will be taken to show appreciation for the volunteer worship leaders and food servers. Whenever possible gather funds from your attenders and forward to us one check instead of individual checks from each attender. Never send us cash.

You may request additional slots at any time, if they are still available, by paying the additional deposits. It would be wise to call ahead to verify availability. Slots will be reserved on a first paid basis until the maximum capacity for this event has been reached.

Unused slot deposits and payments will not be refunded. You are encouraged to transfer these slots to other attenders.

General Requirements Posted by Lost Canyon Camp

The participants are expected to leave the property, including rooms, in a clean condition.

The group contact listed above is expected to pay for any damages to the property and equipment beyond normal wear and tear, including graffiti. Any incident of graffiti vandalism will be assessed a minimum fee of \$50 per incident.

The following are not permitted on the property: pets, alcoholic beverages, illegal drugs, firearms, knives, fireworks, or explosives. As a result, please do not allow your group to transport these types of objects to the property at all.

Smoking is permitted only in the designated smoking area on the property.

Guests are expected to adhere to the guidelines stated above, posted on the grounds, and/or published in the event registration information.

Participating Group Agreement between Your Group and the Organizing AZSBC Churches

We acknowledge that participation in the event described herein involves risks to the participants, the participant's church and the participant's family, and may result in various types of injury including, but not limited to, the following: sickness, bodily injury, death, emotional injury, personal injury, property damage and financial damage.

In consideration for the opportunity to participate in the event and optional facility activities the participating group and attendees acknowledges and accepts the risks of injury associated with participation in and transportation to and from the event. Further, the participating group releases and promises to indemnify, defend, and hold harmless the organizing churches for any injury arising directly or indirectly out of the event, activities or transportation to and from the event, whether such injury arises out of the negligence of the retreat center, the organizing churches, the participant, or otherwise.

If a dispute over this agreement or any claim for damages arises, the participating group agrees to resolve the matter through a mutually acceptable alternative dispute resolution process. If the participating group and the organizing churches cannot agree upon such a process, the dispute will be submitted to a three-member arbitration panel for resolution pursuant to the rules of the American Arbitration Association.
